**POLL RESULTS OF THE EXTRAORDINARY GENERAL MEETING
HELD ON 29 JUNE 2020**

Reference is made to the circular (the “**Circular**”) and the notice of the extraordinary general meeting (the “**EGM Notice**”) of Prosper Construction Holdings Limited (the “**Company**”), both dated 8 June 2020. Capitalised terms used herein shall have the same meanings as defined in the Circular unless the context requires otherwise.

POLL RESULTS OF THE EGM

The Board is pleased to announce that the ordinary resolutions (the “**Resolutions**”) set out in the EGM Notice were duly passed by the Shareholders by way of poll at the EGM held on 29 June 2020.

As at the date of the EGM, the total number of issued Shares was 800,000,000 Shares. Qingdao West Coast Holdings and its associates, in aggregate holding 498,000,000 Shares as at the date of the EGM, are required to abstain from voting on the Resolutions to approve the Construction Services Framework Agreement, the transactions contemplated thereunder and the Annual Caps. Accordingly, the total number of Shares entitling the Independent Shareholders to attend and vote for or against the Resolutions was 302,000,000 Shares. There was no restriction on any Independent Shareholders casting votes on any of the Resolutions at the EGM. Save as disclosed above, none of the other Shareholders were required to abstain from voting at the EGM and there were no Shares entitling the Shareholders to attend and vote only against the Resolutions at the EGM, nor any of the Shareholders had stated their intention in the Circular to vote against or to abstain from voting on the Resolutions at the EGM.

The Company's branch share registrar in Hong Kong, Tricor Investor Services Limited, was appointed as the scrutineer for the purpose of vote-taking at the EGM. The poll results taken at the EGM in respect of the Resolutions were as follows:
