Terms of reference of the Audit Committee ("Committee") of the Board of Directors ("Board") of the Company 董事會(「董事會」)審核委員會(「委員會」)

職權範圍

1. <u>Constitution</u>

1.1 The Committee is established pursuant to a resolution passed by the Board at its meeting held on 22 June 2016.

組成

本委員會是按本公司董事會於2016年6月22日 會議通過成立的。

2. Appointment and composition

2.1 **Appointment and revocation**: Members of the Committee shall be appointed and removed by the Board. An appointment of Committee member shall be automatically revoked if such member ceases to be a member of the Board.

委任及組成

委任及罷免:委員會的成員由董事會委任及罷免。如該委員會成員不再是董事會的成員,該 委員會成員的任命將自動撤銷。

2.2 Composition:

組成:

Members of the Committee shall:

(1) be appointed from amongst the non-executive directors of the Company (including independent non-executive directors of the Company) only;

(1) 只委任自本公司非執行董事(包括獨立非執行董事);

- (2) consist of not less than three in number, a majority of whom should be independent non-executive directors of the Company;
- (2) 最少有三名成員,當中大部分需為本公司的獨立非執行董事;
- (3) consist of at least one independent non-executive director with appropriate professional qualifications or accounting or related financial management expertise as required in **Rule** 3.10(2) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited ("Listing Rules"); and
- (3) 至少有一名成員是由具備有香港聯合交易 所有限公司證券上市規則(《**上市規則**》)第 3.10(2)條所要求的適當專業資格或會計或 相關財務管理知識的獨立非執行董事擔 任;及
- (4) not be a former partner of the Company's existing auditing firm who had ceased as a partner of that firm or to have any financial interest in that firm, whichever is the later, for a period of less than two (2) years.
- (4) 不得由現時負責審計本公司帳目的核數公司的前任合夥人擔任,若該前任合夥人在終止成為該公司合夥人或不再享有該公司財務利益的日期,以日期較後者為準,少於兩年。
- 2.3 Chairman of the Committee: The Chairman of the Committee shall be appointed by the Board or elected among the members of the Committee and shall be an independent non-executive director.

- 2.4 Secretary of the Committee: The company secretary of the Company shall be the secretary of the Committee. In the absence of the secretary of the Committee, Committee members present at the meeting may elect among themselves or appoint another person as the secretary for that meeting.

3. Proceedings of the Committee

3.1 Convening of meetings:

A Committee member may and, on the request of a Committee member, the secretary to the Committee shall, at any time summon a Committee meeting. The external auditors may request the Chairman of the Committee to convene a meeting, if they consider that one is necessary.

3.2 *Notice*:

(1) Unless otherwise agreed by all the Committee members (either orally or in writing), a meeting shall be called by at least seven days' notice. Irrespective of the length of notice being given, attendance of a Committee member at a meeting constitutes a waiver of such notice unless the Committee member attending the meeting attends for the express purpose of objecting, at the beginning of the meeting, to the transaction of any business on the grounds that the meeting has not been properly convened.

(Note: Pursuant to paragraph A.1.3 of Appendix 14 to the Listing Rules, regular meetings should be called by, so far as practicable, at least 14 days' notice.)

(2) Notice of meeting shall be given to each Committee member, and to any other person invited to attend, in person orally or in writing or by telephone or by email or by facsimile transmission at the telephone or facsimile or address or email address last notified to the secretary of the Committee by such Committee member or in such other

- (4) Notice of meeting shall state the purpose, time and venue of the meeting.

3.3 **Quorum:** The quorum of the Committee meeting shall be two members of the Committee.

3.4 Attendance:

(1) The Company's staff having accounting and financial reporting functions, the Head of Internal Audit (or any officer(s) assuming the relevant functions but having a different designation) and

3.6 *Vote:*

(1) A member of the Committee must abstain from voting on any resolution of the Committee in which he or any of his close associates (as defined in the Listing Rules) has a material interest and shall not be counted towards the quorum of such a meeting at which the relevant resolution is considered by the Committee, unless the exceptions set out in the articles of association of the Company or note 1 to Appendix 3 to the Listing Rules apply.

5. Alternate Committee members

5.1 A Committee member may not appoint any person as his alternate.

6. Authority of the Committee

- 6.1 The Committee may at the costs of the Company exercise the following powers:
 - (1) to seek any information it requires from any employee of the Company subsidiaries (hereinafter and its collectively referred to as "Group") professional any advisers and (including auditors), to require any of them to prepare and submit reports and to attend Committee meetings and to supply information and address questions the raised the by Committee;
 - (2) to monitor whether the Group's management has, in the performance of their duties, infringed any policies from time to time set by the Board or any applicable laws, rules, regulations and codes (including the Listing Rules and other rules, regulations and

- (12) where the Board disagrees with the Committee's view on the selection, appointment, resignation or dismissal of the external auditors, to explain the Committee's own recommendation on such matters in the form of a statement by the Committee, which statement together with the reasons why the Board has taken a different view shall be included in the corporate governance report of the Company;

- 6.2 The Committee shall be provided with sufficient resources to perform its duties.

7. **Duties of the Committee**

7.1 The duties of the Committee shall be:

(1) to act as the key representative body

- (8) to discuss problems and reservations arising from the interim and final audits, and any matters the auditors may wish to discuss (in the absence of management where necessary);

- (12) where an internal audit function exists, to ensure co-ordination between the internal and external auditors, and to ensure that the internal audit function is adequately resourced and has appropriate standing within the Company, and to review and monitor its effectiveness;
- (13) to review the Group's financial and accounting policies and practices;
- (14) to review the external auditor's management letter, any material queries raised by the auditor to management about accounting records, financial accounts or systems of control and management's response;
- (15) to ensure that the Board will provide a timely response to the issues raised in the external auditor's management letter;

- (17) to prepare work reports for presentation to the Board and to prepare summary of work reports for inclusion in the Group's interim and annual reports;
- (18) to review arrangements employees of the Company can use, in confidence, to raise concerns about possible improprieties in financial reporting, internal control or other matters. The Committee should ensure that proper arrangements are in place for fair and independent investigation of these matters and for appropriate follow up action;

- (19) to report back to the Board on any of the matters set out above as well as their decisions or recommendations, unless there are legal or regulatory restrictions on their ability to do so (such as restriction on disclosure due to regulatory requirements); and
- (20) to consider other matters, as defined or assigned by the Board from time to time.

8. Veto rights of the Committee

8.1 The Committee has the following veto rights. The Group cannot implement any of the following matters which has been vetoed by the Committee:

- (1) to approve any connected transaction within the meaning of the Listing Rules which requires an independent shareholders' vote (unless the approval of such connected transaction is made conditional on the obtaining of the approval of the independent shareholders); and
- (2) to employ or dismiss the Group's financial controller or the internal audit manager.

9. Minutes and records

- 9.1 The secretary of the Committee shall, at the beginning of each meeting, ascertain and record the existence of any conflicts of interest and minute them accordingly.
- 9.2 Full minutes of the meetings of the Committee and all written resolutions of the Committee shall be kept by the secretary of the Committee.
- 9.3 The secretary of the Committee shall circulate the draft and final versions of minutes of the meetings of the Committee to all Committee members for their comment and records within a reasonable time after the meeting (generally, meaning within 14 days after the meeting). Once the minutes are properly signed, the secretary of the Committee shall circulate the minutes and reports of the Committee to all members of the Board.
- 9.4 The secretary of the Committee shall keep record of all meetings of the Committee held during each financial year of the Company and records of individual attendance of members of the Committee, on a named basis, at meetings held during that financial year.

10. Annual general meeting

委員會秘書應於委員會會議結束後的合理時段內(一般指委員會會議結束後的14天內),把委員會會議紀錄的初稿及最後定稿發送委員會全體成員(初稿供成員表達意見,最後定稿作其紀錄之用)。會議紀錄獲簽署妥當後,委員會秘書應將委員會的會議紀錄和報告傳閱予董事會所有成員。

委員會秘書應就年內委員會所有會議紀錄存 檔,以及具名紀錄每名成員於委員會會議的出 席率。

10.1 The chairman of the Committee or in his absence, another member of the Committee, shall attend the annual general meeting of the Company to answer questions at the annual general meeting on the Committee's activities and their responsibilities.

10.2 The Company's management should ensure the external auditor attend the annual general meeting to answer questions about the conduct of the audit, the preparation and content of the auditors' report, the accounting policies and auditor independence.

11. <u>Continuing application of the articles of association of the Company</u>

11.1 The articles of association of the Company regulating the meetings and proceedings of the Directors so far as the same are applicable and are not replaced by the provisions in these terms of reference shall apply to the meetings and proceedings of the Committee.

12.1 The Board may, subject to compliance with the articles of association of the Company the Listing Rules and (including the Corporate Governance Code set out in Appendix 14 to the Listing Rules or if adopted by the Company, the Company's own code of corporate governance practices), amend, supplement and revoke these terms of reference and any resolution passed by Committee provided that amendments to and revocation of these terms of reference and the resolutions passed by the Committee shall invalidate any prior act and resolution of the Committee which would have been valid if such terms of reference or resolution had not been amended or revoked.

13. Publication of the terms of reference of
